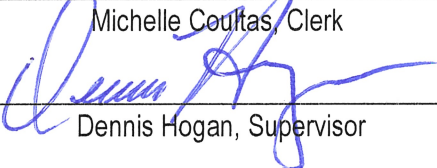
CORRESPONDENCE: None.
